- II. FIRM SHOULD SUBMIT LIST OF MANPOWER AND MACHINERIES TO DISPLAY CAPABILITIES OF EXECUTING WORK.
- III. FIRM HAS TO EXECUTE THE JOB STRICTLY AS PER ANNEXURE ENCLOSED. FIRM IS ALSO REQUIRED TO UPLOAD A duly SIGNED AND stamped COPY OF ENCLOSED ANNEXURE INDICATING ACCEPTANCE OF EACH AND EVERY TERM INDICATED THEREIN.

F. Ambajhari. EMD will have to reach factory on or before the closing date.
