


SPECIAL TERM AND CONDITIONS FOR THE MACHINING OF 250 Kgs. AERIAL BOMB BODY (OUT SIDE GIF PREMISES)

- 1. These term and conditions are restricted for machining of 250 kgs. Aerial Bomb Body to be carried out in the firm's premises as per Drg No. ARDE 9501-01.
- 2. GIF will issue castings as per drawing no.GIF 70-5397. Transportation of casting from GIF and delivering back the machined bomb bodies to GIF shall be completely firms responsibility (Including loading and unloading at both ends)
- 3. To qualify for technical suitability in two bid system, the firm must have following machines and other infrastructure capable of undertaking above said machining. Please note that the minastructure shown below is bare minimum requirement for capability demonstration and it is not the complot set of machines required for undertaking the said job.
 - Suitable overhead crane/material handling arrangement capable of handling the bomb body.
 - (ii) Conventional lathe capable of rough**O**D turning of the casting.
 - (iii) At least two CNC lathe out of which one is capable of undertaking ID operation (i.e.
 I.D. turning of the bomb body as per machining Drg No. ARDE 9501-01.
 - (iv) CNC Horizontal machining centre capable of tail end (large dia of the bomb body)
 side operations.
 - Suitable drilling/milling machine for undertaking bomb body drilling operation for lug welding.
- 4. The firms claiming to have above said facilities shall be subjected to capacity verification by GIF team whose decision regarding suitability/capacity of the machine and the infrastructure shall be final.
- 5. Apart from others, the supply order execution shall governed by the following terms and conditions-
 - A) Minimum 06 nos. of castings shall be provided at a time.
 - B) Casting having blow holes less than 12 nos. can be rectified by welding subject to depth of blow hole less than 1/3rd of the wall thickness and diameter less than 12 mm shall be rectified by the firm keeping in mind that the density of leaky holes shall not be more than 04 holes within a radius of 25 mm and holes shall be not touching each other by the electrodes of nearly same chemical composition of the bomb body casting.
 - C) After welding, the area of the blow holes will be grinded & machined to match the adjacent surface. Castings having more blow holes or greater depth of blowholes will be returned without rectification as bad material.

- D) The casting found defective during machining (for which machining could not be completed) due to casting defects (as mentioned in point no.-4(B)) are to be returned to GIF as bad material (BM). Firm will not be entitled to claim any machining charges for the rejected & defective casting during machining. Replacement of such bad material will be provided by GIF without any cost implication on either side.
- E) For the machined bomb bodies rejected at GIF due to machining defects such as castings having tool marks, chattering marks, dimensions not as per drawing etc. The firm will not be paid for the machining charges up to 1% rejection. Beyond 1% rejection, apart from not providing machining charges, cost of the bomb body casting will also be recovered from the firm bills.
- F) The cause for the rejection of machined casting (whether it is due to machining defects or casting defects) will be decided by GIF.
- G) The machined bomb body rejected due to inherent casting defects like cracks, pin holes etc, but accepted in respect of all machining dimensions, the firm will be paid for machining of that casting.
- H) The steel swarf/scrap generated during machining of the castings will be retained by the firm and only finished machined castings are to be supplied back to GIF. Accordingly, the firm will quote the rate for machining of casting after adjusting the value of swarf/scrap.
- I) The machined casting should be returned back to GIF within a period of two weeks from the date of receiving the castings at firm's premises. In case of delay on the part of the firm resulting into production discontinuity at GIF, as a matter of penalty, a token amount@ Rs.100/- per casting per day shall be charged.
- J) The firm will be issued Job completion certificate every month by the user section for the machined castings after final acceptance by AQAW (A) in GIF against which the firm can raise bill for claiming payment.
- 6. Firm has to prove its machining capability by machining one casting on No cost- No commitment (NC-NC) basis. The firm has to lift the casting by submitting the material security deposit (MSD) as asked by Material Management Group (MMG), which should be submitted after order placement.
