1	Electro Block Unit, BL2.300.041	The item is meant for the formation of electric signals required for working for stabilizer and consists of protection and unlocking device, current analyser of Gyro Motor, guiding channel, voltage converter, power amplifier, supply block & series of auxiliary blocks (diode blocks)	50 Nos.
2	Gun Position Sending Unit, BL2.320.040	The items is meant for developing voltage proportional to mismatching of angle between sighting line of device and longitudinal axis of gun barrel in vertical plane and consists of sensor unit, parallelogram with arm flange and rotary transformer.	50 Nos.

TERMS AND CONDITIONS OF EOI

1. Vendors are required to submit an overview (within 30 days from the date of publication) about their company like manufacturing capabilities, financial standing etc. This shall be scrutinized by OLF before issue of relevant drawings, technical documents, etc.
 2. After obtaining relevant technical documents and drawings of the items from OLF, the vendors are requested to study the drawings and technical documents thoroughly if felt necessary, the vendor's representative may visit OLF with prior appointment to understand exact requirement.
 3. Vendors will ensure that design of the item will remain same as original.
 4. Vendors are requested to submit "Expression of Interest" along with the following information in detail within 30 days from the date of issue of drawings.
 - a) Manufacturing Plan and QA plan for the subject item.
 - b) Manufacturing facilities including machines, capacity, trained manpower etc.
 - c) Testing facilities.
 - d) Quality system certification(s), including ISI-9001 & AS 9100 C certified.
 - e) List of customers to whom similar types of items are being supplied.
 - f) Duly filled Vendor registration request form (VRRF) which can be down loaded from website <http://ofbindia.gov.in> (under policies) and the same is attached.
 5. Vendors who are having valid registration with any of the Ordnance Factories for similar items need not to submit VRRF as para 4.f above. Such vendor must mention 30 digit registration number with its validity.
 6. If found qualified, the capacity verification will be done by OLF team.
 7. Vendors whoever has qualified technically for the subject item will be eligible for issuance of Tender Enquiry.
 8. Vendor shall sign non-disclosure agreement with OLF.
