B. Other standard terms and conditions will be as under:

1) Firm has to arrange the inspection facilities and requisite test certificates from Govt. approved / NABL Lab. Firm must confirm the same in technical bid.

2) All the required facilities, whether in-house or outsourced should be capable and suitable for producing the component as per quality requirement projected in the monitoring instruction/drawings/specifications. Firm must confirm the same in their technical bid along with self-declaration of capability of firm and its sub vendors.

3) The firm has to arrange for suitable packing of the stores to protect the store damage during storage & transit deterioration, if firm gets the order. Firm must confirm the same in their technical bid.

4) The firm shall have supplied same/similar category of items to other firms. The firm will provide the details of same/similar category of items supplied to other firms in last three year with details of purchaser.

5) The criteria of Arming that is RPM at which Booster Sub Assy with Set Back Mechanism should not Arm and RPM at which it should Arm shall be 1200 and 2000 RPM respectively. Firm must confirm to the clause in their technical bid.
